Old business:

- Libby H. provide a round-up regarding the swag shop.

 - Board discussed the option for next time to try doing 1 drop shipment and have orders picked up at Annual Meeting

New business:

- Libby H discussed recent phishing attempt going out to some WNA residents. Email ask for recipient to purchase gift cards. This is a scam, please do not purchase gift cards for Libby or any other WNA board members
- WNA competed a second grant request to the Indianapolis Neighborhood Resource Center (INRC)
 - o Request is for max amount: \$10,000
 - Includes:
 - 6 additional WNA street signs, for interior of neighborhood
 - 30 reusable signs for events
 - Shed (6' x 8') to store signs and other property of WNA
 - Libby H is talking with St. Paul about having shed on their property
 - Midtown was fiduciary on previous grant, but WNA is working with BRVA to be fiduciary on this funding due to our 501c3 status.
- Libby H discussed the 2024 Annual Meeting
 - o March 12th, 2024
 - o Confirmed guest: Councilor Brienne Delaney
 - Board discussed other potential guests and will work to confirm
 - Topics for discussing will likely be:
 - Triangle Property (BRVA), by St. Paul's
 - By Laws Update
 - Directors' insurance

Additional business:

- Jim P provided an update on the levee

 - Still uncertain exactly how rehab/remodel will work post approval
 - o Most properties will fall in Zone X, but it appears a few properties will fall into Special

Flood Hazard Area.

- o Jim P will continue to follow up with DPW
- Jim P asked about WNA obtaining federal 501c3 status so we can facilitate and administer grants that may have federal dollars
 - Directors noted this has been discussed; however, the additional time, costs, and expertise needed so far have not proven worth the effort as most grants will be state or local funding
